It wasn't just the fact that we managed to deliver really good portfolio performance, it was the fact that we were available and talking to clients at whatever frequency was appropriate to them. I am so proud of what the team achieved. We didn't go missing, we upped our game."

JH&P's Head of Marketing and UK Business Development, Helen Rynhoud, said: "It's a tribute to the strength and commitment of the team and the quality of our service that we've won these awards. I'm particularly pleased that we won the ESG award. Sustainability is embedded in the way JH&P manages all client portfolios. This year we've worked hard to articulate more clearly what we do, and it is fantastic to receive an award that recognises our approach ahead of a group of very strong competitors."
